**WHEREAS**, the Sheriff is requesting that available funds from the Special Jail Fees revenue fund (#3017) be moved into two GL line items, one in the Special Jail Fees Budget and one in the County General Budget for purpose of appropriate assignment of expenditures.

**WHEREAS**, there are sufficient funds available in the Special Jail Fees Fund for said transfer.
